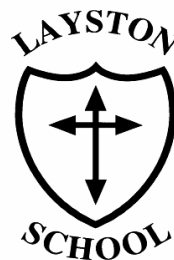

Limited parking space and the split levels of the school mean that several disabled bays would be needed and this simply isn't practical. The current arrangement has proved practical and effective.
	Accessibility ramp to be provided to the side of the school	Investigate the practicalities of procuring a disabled ramp	School would be more accessible	As and when funding can be secured	Access to the exterior of classrooms, this however does not solve the issue of wheelchairs being able to enter the reception, Y1 or Y2 classrooms and move around the school to access key areas given split site.	Governors have investigated, current estimates are that this project would cost around £20k. However, there is insufficient space to the side of the school to set a ramp unless it is to be exceptionally steep. Whilst Governors aspire for the site to be totally accessible to all, the reality of old buildings on a split site and a small school budget is that this cannot be achieved without considerable external investment.
